

Privacy Policy

1. Introduction

At Dutch Wind Music, we take your privacy seriously. We collect, use, and protect your personal information in accordance with the General Data Protection Regulation (GDPR) and other applicable privacy laws. This privacy policy explains how we handle your data when you use our website www.dutchwindmusic.com, www.dutchwindmusic.eu and www.antonweeren.com and the services we offer.

2. What Data Do We Collect?

We collect the following types of data:

- **Personal Information:** such as your name, email address, and other contact details that you provide when subscribing to our newsletter or placing an order.
- **Technical Information:** such as IP addresses, browser data, and information about your visit to our website (for example, the pages you visit, the duration of your visit, etc.) through cookies and other technologies.
- **Payment Information:** if applicable, payment details are collected to process orders, such as credit card information. This data is processed by a third-party payment processor and is not stored on our servers.

3. How Do We Use Your Data?

We use your data for the following purposes:

- To send you newsletters, updates, and other information you have requested.
- To process orders and requests.
- To improve our website and services based on your use and interaction.
- For administrative purposes, such as managing your account and providing customer support.
- To comply with legal obligations.

4. Sharing Your Data

We do **not** share your data with third parties, except:

- **Payment Processors:** For payments made through the website, we may share your data with our payment partners, such as payment processors (e.g., Stripe or PayPal).
- **Service Providers:** We may engage external service providers to host the website, send emails, or improve website functionality. These third parties only have access to the data they need to perform their services and are not allowed to use it for other purposes.

5. Cookies

Our website uses cookies to enhance your experience and analyze website usage. Cookies are small text files that are stored on your device. You can block or delete cookies through your browser settings, but this may affect the functionality of the website.

6. Data Security

We take reasonable precautions to protect your personal information from loss, theft, or unauthorized access. While we strive to keep your data secure, we cannot guarantee 100% security, as no method of data transmission or storage is entirely secure.

7. Your Rights

You have the following rights regarding your personal data:

- **Right to Access:** You have the right to know what personal data we have collected about you.
- **Right to Rectification:** You can request that we correct any inaccurate or incomplete data.
- **Right to Erasure:** You can request that we delete your data, unless we are required to retain it for legal purposes.
- **Right to Restrict Processing:** You can ask us to limit the processing of your data in certain circumstances.
- **Right to Object:** You can object to the use of your data for specific purposes, such as direct marketing.
